The Correspondent, Top Kids School, JKC College Road, Adavithakkellapadu, Guntur is informed that opening permission has been accorded to their school with classes I to VIII (E.M) during the academic year 2023-2024 without aid now or in future in the reference (10) read above. The Deputy Educational Officer, Guntur, Guntur District has recommended for Recognition to classes I to VIII (EM) for the period from 2023-2024 to 2030-2031 without aid now or in future vide reference (11) read above. The District Educational Officer, Guntur has verified the application for Recognition to classes I to VIII (E.M.) for the period from 2023-2024 to 2030-31 without aid now or in future with reference to the inspection report of the inspecting officer and also with the reference to the conditions laid down in the reference (10) read above and G.O.Ms.No.1 Edn., (PS-I) Department, dated 01-01-1994 and submitted a report in the reference (12) read above with recommendation.

After careful examination of the above said proposals and the conditions prescribed in G.O. Ms. No. 1 Edn, dated 1-1-1994, G.O.Ms.No.41 Edn, dated 11-05-2006, G.O. Ms. No. 74 Education dated 11-09-2006, G.O. Ms. No.38 Edn., dated 22-04-2023 and as per the instructions issued by

the Government/Commissioner of School Education, Andhra Pradesh, Amaravati in the references 1st to 9th read above, the Regional Joint Director of School Education, Guntur is hereby accords Recognition to classes I to VIII (E.M) for a period of 8 years i.e., from 2023-2024 to 2030-2031 without aid now or in future in respect of Top Kids School, JKC College Road, Adavithakkellapadu, Guntur. However by the end of April every year, the educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abide the instructions, rules and regulations made by Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time.
4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
5. That the qualified staff within the age limits prescribed by Govt., for Govt., employees shall be appointed as per the Staff pattern.
6. That the results of the institutions shall be satisfactory every year.
7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to close only from the date on which summer vacation is declared.
13. That the society shall submit proposal for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal of recognition.
14. The recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the recognition now being given is liable to be withdrawn at once.
15. The Management is requested to follow the instructions of the Fire Service Department and renewal the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Guntur and District Educational Officer, Guntur.

16. The Management is requested to renew the Vehicle Fitness Certificate, NOC issued by the Fire Services Department, NOC issued by the Traffic Police and also obtain Structural Soundness Certificate and Sanitary Certificate every year from the concerned authorities without fail and submit the same to the District Educational Officer, Guntur through the concerned Deputy Educational Officer, Guntur, Guntur District.

17. Economic Strength should be maintained in all classes and it should be improved during this academic year.

18. Latest Traffic NOC from the Police Department should be within 1 month without fail.

19. Endowment Fund should be pledged in the name of the DEO concerned immediately. Lease Deed towards play ground should also be submitted.

Further, the managing committee of the school is requested to fulfill all the requirements to cope up with the needs of the institution at the latest before submitting the application for Renewal of Recognition for the year 2031-2032.

The receipt of these proceedings should be acknowledged.
